Agenda Item #1. Emergency Declaration / closing city buildings. Superintendent Greg Sjuts was present to speak on what the schools were doing to deal with the COVID 19 pandemic. Currently all schools are closed with re-evaluations to be done every 2 weeks. Jim Wiehn was also present to talk about the rescue unit and their preparation for calls. Mayor Weidner suggested adopting an emergency declaration limiting 50 people or less at the Community Center, bars, restaurants and to temporarily close the library. Police Chief Miller spoke with the City Attorney Dan Fullner, and it was Fullner's suggestion to limit liability and to follow the CDC and East Central District's recommendations for no more than 10 people at bars and restaurants. Police Chief Miller had already talked to Kudron's, Mugs & Jugs and the bowling alley and they were in agreement to the guidelines. A motion was made by Nolan and seconded by Preister to adopt the City of Humphrey Declaration of Health Emergency limiting the bars and restaurants to 10 or less people, close the Community Center to events until May 11 and to temporarily close the Library to public access. The motion carried on the following roll call vote: Yeah: Preister, Eisenmenger, Nolan Nay: None. Absent: Reigle. The plan will be reevaluated every 2 weeks. A copy of the plan is attached hereto.

Agenda Item #2 - Gerry Sander – Discussion of the Maintenance Position opening. Mr. Sander was not present at the meeting. No action was taken.

Agenda Item #3 - Pivot tires – review bids for cost of new tires. A motion was made by Eisenmenger and seconded by Preister to accept the bid of HD Diesel Repair for pivot tires and rims for the cost of \$10,865.76. The motion carried on the following roll call vote: Yeah: Preister, Eisenmenger, Nolan Nay: None. Absent: Reigle.

Agenda Item #4 -. Tony Miller – request from Zoning Board to change the setback requirements. The Zoning Board had a hearing to change the setbacks for the R-2 medium to high density residential districts for side yards from 15 feet to 4 feet. They are recommending to the Council to make the change to the setbacks. A hearing on the issue will be held on April 6, 2020 at 7:00 p.m. at the Community Center.

Agenda Item #5- Review and approve street sweeping agreement with Gehrings for 2020 - \$4650. A motion was made by Eisenmenger and seconded by Preister to approve the street sweeping agreement with Gehrings not to exceed \$4650 for 2020.
