He requested the Council review his assessments and take that into consideration. William Rizman requested information on whether Third Street North was assessed to the property owners and if both the alley improvements around Main Street were assessed. That information wasn't readily available at the time, but the Council will have that at the December meeting.

Agenda Item #1. Approve Resolution No. 890 – Year End Certification of City Street Superintendent – A motion was made by Reigle and seconded by Nolan to approve Resolution No. 890 – Year End Certification of City Superintendent and authorizing the Mayor to sign the year-end certificate. The motion carried on the following roll call vote: Yeah: Reigle, Nolan, Eisenmenger Nay: None. Absent: Preister.

Agenda Item #2. Discuss / approve the lagoon closing bids and award/reject the project. John Zwingman, City Engineer, presented the two bids received for the lagoon closing. Doernemann Construction was low bidder with a bid of \$546,125.06 and Obrist & Company was the only other bidder with a bid of \$599,490.00. The Engineer's estimate was \$350,000.00. At this time, Zwingman recommended rejecting both bids. A motion was made by Reigle and seconded by Nolan to reject the bids for the lagoon closing.
